Re: Rounding Rules for Behavioral Health Services after COVID-19 Crisis

Recently MMP 23-10 Telemedicine Policy Post-COVID-19 Public Health Emergency was issued. The telemedicine policy post COVID will become effective May 12, 2023. This communication is to notify you that the 15-minute rounding rules for behavioral health services provided via telemedicine that was put into place during the COVID-19 emergency will end on May 11, 2023.

Rounding rules will return to what they were prior to the public health emergency. As a reminder these are found on the General Rules for Reporting tab within the SFY 2023 Behavioral Health Code Charts and Provider Qualifications workbook. Fifteen-minute HCPCS codes will need to reach the full 15-minutes to be billable.

GENERAL RULES FOR REPORTING

1a. Rounding rules for HCPCS reporting:
